Will Georgia Power charge new data centers?

Georgia Public Service NEWS RELEASE January 23,2025 - (ATLANTA) The Georgia Public Service Commission voted unanimously on Thursday to approve a new rule that allows Georgia Power to charge new data centers in a manner that will protect ratepayers from cost shifting.

Does Georgia have a new power grid?

In April 2024, the PSC approved expanding Georgia's power grid to accommodate the new data centers. But now, customers using more than 100 megawatts of energy -- enough to power tens of thousands of homes -- will be billed under new terms and conditions separate from the average customer.

How do Georgia Power franchise fees work?

Franchise Fees are collected based on electric service inside or outside of city limits. If you live within the city limits of a city with which Georgia Power does NOT have a franchise agreement, you will pay as outside the city limits. If you are not sure, contact GPC at 1.888.660.5890.

Does Georgia Power offer hourly electricity use data?

Hourly Electricity Use Data Georgia Power now offers residential customers access to hourly electric use data through the company's My Power Usage tool available for registered customers on Georgia Power's website. The My Power Usage offers 24-hour graphic visualization of hourly data and electronic download of the data.

Customers must be able to benefit from hourly price signals, furnished at least 60 minutes in advance, and maintain a peak 30-minute demand not less than 5,000 kW each month.

ATLANTA - The Georgia Public Service Commission has approved a new rule allowing Georgia Power to charge new data centers above what normal ratepayers have to pay.
